Perhaps the most familiar trope in the Israeli-Palestinian conflict is Israel's insistence on "secure and recognized borders" in any final settlement. Although a consistent theme of Zionist politics and diplomacy even before the founding of the State of Israel, there has always been an internal debate as to which borders would provide Israel with security and which boundaries must ultimately be recognized by the Arab world. Often overshadowed in the international arena but no less important in Israeli domestic discourse is the relationship between Israeli national identity and the Land of Israel. This course will the explore the evolution of and conflict between these two concepts in Israeli domestic discourse and their respective impact on Israel's territorial policies and international boundaries. After considering the role of security and identity in shaping broad domestic understandings of territory in Israel, we will examine how these concepts have uniquely influenced Israeli compromise or lack thereof in the Sinai Peninsula, Southern Lebanon, the Gaza Strip, the Golan Heights, Jerusalem, and the West Bank. To accomplish this goal, this course will incorporate a range of scholarly historical and political readings on Israel as well as films and regular student-led discussions on relevant current events.

In-Class Presentations:

Beginning in the second week of classes, one or two students will each lead a brief, 10-15 minute in-class discussion regarding a current issue in Israeli politics related to that day's assigned readings. Near the end of class, Each student will speak for no more than 5 minutes regarding their chosen topic and then offer 3 questions for general discussion. Discussions should draw from *at least* two newspaper articles that present contrasting views of the issue under examination as well as from the week's readings. Topics must be chosen at least one week in advance with approval of the instructor, and articles and discussion questions will be emailed to the entire class *no less than 24 hours before class*. Presentations will be scheduled during the first week of classes.

Current Events Analysis:

Students are expected to submit **two** 2-3 page, double-spaced analyses of a current issue in Israeli politics. Like the in-class presentations, analyses should be based on at least two newspaper articles that present contrasting views of the issue as well as the day's readings. Articles should be submitted to the instructor along with the analysis. Students may submit analyses for *any* day they choose so long as they are submitted on two different days and not on the same day as your own in-class presentation.

Attendance & Participation:

Regular attendance of and participation in class discussions is essential to your success in this course. Absences for campus activities, religious observances, personal concerns, etc must be cleared with the instructor in advance barring emergencies so appropriate make-up work can be assigned. Classroom discussions will be open, civil, and mutually respectful. Active involvement in class discussion is strongly preferred, however if you feel very uncomfortable speaking in front of your peers, the instructor can offer alternative assignments for participation credit.

Term Paper:

A significant portion of your grade for this course is tied to the term paper. In it, you are required to critically analyze and evaluate some aspect of Israeli territorial politics discussed in this course. Papers are encouraged to explore the course's central theme of security and identity, applying these concepts to one or more cases of contentious territorial claims in the history of modern Israel. In doing so, your paper should elucidate how these themes have impacted (or perhaps failed to impact) Israeli popular opinion, state policy, conduct in international warfare and negotiations, or the like. Students may choose to focus their papers on a particular time period, disputed space, political ideology, or sector of the Israeli population. Papers may offer policy recommendations regarding their subject although are not required to do so.

In order to assist students in developing the best possible paper and facilitate its timely completion, three benchmark due dates have been scheduled for the submission of a paper proposal, paper outline, and final paper for classes 13, 20, and 28. The **paper proposal** need be no longer than 1-1.5 pages double-spaced with a clearly stated topic, thesis question, and provisional argument. It should also include a basic description of potential sources of information and evidence to test your hypothesis. The **paper outline** should be approximately 5 pages double-spaced with greater detail as to the kinds of arguments and data you will be using to support your arguments. This should be a basic roadmap to your paper. These are as much

opportunities for critical feedback on your work by the instructor as they are tasks to keep you on schedule. *You are encouraged to make the most of them.* Final papers should be no longer than 20 pages excluding bibliographic references, double-spaced, and use 12 point font and 1 inch margins. They are due at the beginning of the final day of class.
